Rana Ebrahimi is the National Manger of the Multicultural Youth Advocacy Network Australia (MYAN). She leads MYAN to advocate for young people from refugee and migrant backgrounds' rights and best interests in policy and practice. Rana is an expert in social inclusion and humanitarian ethics. She is the first Iranian woman to be a National Head of Office for the United Nations High Commissioner for Refugees (UNHCR) in Iran. OLD PARLIAMENT HOUSE MEMBERS' DINING ROOM 2





The Members' Dining Room 2 was the main dining room for the exclusive use of parliamentarians, with direct and stunning views of Australian Parliament House, its own driveway terrace which can be utilised and photogenic bridges that allow a grand entrance off Queen Victoria Terrace. It's high ceilings and original timber lamps, it is an overall beautiful historic backdrop that would be perfect for any event.



Originally, the Members' Dining Room was painted white. However, between the late 1930s until the 1950s it was decorated throughout with an intricate and colourful paint scheme. After carefully scraping back the overlying layers of paint, the decorative effect can now be seen in one section of the northeast corner, revealing this small fragment in time for the eyes of today.

OLD PARLIAMENT HOUSE MEMBERS' DINING ROOM 3





Members' Dining Room 3 was originally the Members' Lounge, a space for the exclusive use of Members and Senators. Considering the building's construction era, Member's Dining Room 3 is recognised for its modern architectural design, featuring two stunning, original skylights. It boasts an impressive view of Australian Parliament House, stunning by both day and night, and its own outdoor terrace space that can be used in conjunction with the room, weather permitting.



What was formally known as the Member's Lounge, this room was recognisable for the deep leather chairs used for morning and afternoon teas and suppers exclusively served for members and senators. Over the years the room featured a radio-gramophone and a selection of records, a grand piano and, by the 1980s, two televisions. In 1948, it was refurbished to allow Members to entertain guests in the space and was re-named the Members' Visitors Room. In later years, the room was used to serve small breakfasts or quick meals for Members who did not have time for the more leisurely service in the main Members' Dining Room.

HON ANDREW GILES MP

Minister for Immigration, Citizenship and Multicultural Affairs.

The Hon Andrew Giles MP is the Minister for Immigration, Citizenship and Multicultural Affairs. He was first elected to the Australian Parliament as Member for Scullin on 7 September 2013, representing the Australian Labor Party (ALP). He is currently serving his fourth term in Parliament representing the Scullin community.

Minister Andrew Giles previously served as Shadow Assistant Minister for Schools from July 2016 to May 2019, and as Shadow Minister for Cities and Urban Infrastructure, Shadow Minister for Multicultural Affairs, and Shadow Minister Assisting for Immigration and Citizenship from May 2019 to May 2022.



HON DR ANNE ALY MP Federal Minister for Early Childhood Education and Minister for Youth

The Hon Dr Anne Aly MP has been the Federal Member for Cowan since 2016 and is also the Federal Minister for Early Childhood Education and Minister for Youth in the Albanese Government.

With a Masters and PhD, she worked as a professor, academic and practitioner in counter terrorism and countering violent extremism and authored the book- Terrorism and Global Security: Historical and Contemporary Perspectives.

The founder of People against Violent Extremism, Dr Anne Aly MP was the only Australian representative to speak at President Obama's 2015 White House summit on countering violent extremism.

Community Development Training Lead Community Refugee Sponsorship Australia

Shabnam Safa is a driven community development practitioner passionate about cultivating true partnerships between communities and structures of power to create social change. She grew up as a Hazara Afghan refugee in Pakistan before arriving in Australia at the age of 15. Grounded in her own experience of forced displacement, she advocates for meaningful participation of refugees in addressing the complex challenges of resettlement, inclusion, and belonging. She is part of a small national team at the Community Refugee Sponsorship Australia (CRSA) building a holistic community-led refugee sponsorship movement in Australia. Born in West Africa, Kwame Selormey lives on Larrakia Country in the NT. He is the CEO of Melaleuca Australia, a non-profit organisation that supports humanitarian entrants, migrants and people from CaLD backgrounds to settle in the NT, alongside generalist employment services. Caitlin Figueiredo is determined to give young people a say in politics.

In 2015, she worked to bring young people's voices into parliament through a national youth advisory council.

This led to her election to the Australian Youth Affairs Coalition (AYAC) board, a volunteer position that she juggled with university work – and a political leadership group she co-founded called Girls Take Over Parliament. Caltlin revitalised and transformed AYAC, creating a more diverse board that better represented young people.

Thanks partly to Caitlin's work, in 2022 the Australian Government established a dedicated Minister for Youth and invested \$10.5 million into youth affairs to ensure young people would have a share in decision-making and policy design.
