MYAN's bi-annual youth leadership event FUSE 2023 was held in conjunction with our National Multicultural Youth Conference which brought together a wide range of MYAN stakeholders including young people from across Australia, MYAN's youth advisory bodies and state and territory partners, and experts from the youth, migration and settlement sectors as well as members of parliament.



FUSE 2023 'Connect, Ignite, and Trailblaze'



FUSE is a bi-annual national multicultural youth leadership summit hosted by MYAN. FUSE is specifically designed to equip a national network of emerging leaders with the skills, confidence, and networks needed to create meaningful change in their communities, at the state and national levels.



Framed by the overarching themes of 'Connect', 'Ignite', and 'Trailblaze', FUSE brings together emerging young leaders from refugee and migrant backgrounds from across Australia to develop skills, expand their networks, and engage in advocacy with decision-makers.

MYAN's national Youth Ambassadors Network (YAN) plays an important role in designing and delivering FUSE. The content and structure of the program is targeted to the needs, rights and context of young people form refugee and migrant backgrounds, with delegates supported to apply their skills and knowledge at local levels post-FUSE with the support of MYAN's state and territory partners.



FUSE brings together emerging young leaders from refugee and migrant backgrounds from across Australia to develop skills, expand networks, and engage in advocacy with decision-makers.



FUSE 2023 was held in Canberra for the first time, on the 26th-28th November 2023. The purpose of FUSE 2023 was to provide a platform for aspiring young leaders to engage directly with policymakers and decision-makers, to present innovative ideas aimed at resolving critical challenges affecting young people from refugee and migrant backgrounds in Australia.



Rationale



FUSE is grounded in MYAN's understanding of youth participation, advocacy and leadership for young people from asylum-seeker, refugee and migrant backgrounds. MYAN believes that young people have unique experiences and knowledge as experts in their own lives and should be supported to identify and explore the issues impacting them, find solutions and advocate for positive change.

Young people from refugee and migrant backgrounds possess remarkable strengths and capabilities, with tremendous potential to contribute to Australian society. However, these individuals frequently confront challenges in accessing the support and opportunities necessary to achieve their full potential. Unfortunately, the specific barriers they face can place them at greater risk of social and economic disadvantage than their Australian-born peers.

These barriers include, but are not limited to: Western standards of healthcare, limited culturally safe and appropriate mental healthcare, social disconnection due to racism and discrimination, a "one size fits all" approach by service providers, and a lack of meaningful engagement with decision makers. Consequently, their voices can be marginalised, limiting their capacity to advocate for their needs, influence decision makers, and be supported as leaders in their communities.



As the national peak body representing the rights and interests of young people from refugee and migrant backgrounds in Australia, MYAN plays a pivotal role in facilitating access to leadership and advocacy opportunities for diverse young people. MYAN believes that young people should be encouraged to identify, explore, and respond to issues affecting their lives, identify solutions, and advocate for change. FUSE is a critical event that supports young people in these endeavors.

FUSE seeks to put youth voices on the agenda for policy makers. The primary aim of FUSE is to promote the voices, values, and aspirations of young advocates from refugee and migrant backgrounds, highlighting key issues impacting young people across the country. Additionally, FUSE promotes young people from refugee and migrant backgrounds as powerful advocates—engaged, articulate, and cohort to be taken seriously in the public forum.



Through FUSE, MYAN is committed to promoting the leadership and advocacy of young people from refugee and migrant backgrounds, empowering them to drive change and contribute to a more inclusive, socially cohesive Australia.





FUSE Aims

Primary

To promote the voices, values, and aspirations of young advocates from refugee and migrant backgrounds and highlight key issues impacting young people across the country. FUSE aims to put youth voices on the agenda for policy makers.

Secondary

To promote young people from refugee and migrant backgrounds as powerful advocates who are engaged and articulate; a cohort to be taken seriously in the public forum.

MYAN's FUSE conference provides opportunities for young Australians from refugee, asylum seeking and migrant backgrounds to:

- Connect with and share perspectives, and experiences with other young people from multicultural backgrounds from around Australia
 - Explore and strengthen leadership capabilities and aspirations
 - Build skills, confidence and networks to engage in advocacy and active citizenship
 - Apply advocacy and leadership skills and engage with decision-makers
 - Access national opportunities through networking with organisations and advocacy bodies
 - Provide an opportunity for decision-makers to engage directly with young people from multicultural backgrounds from around Australia.



FUSE 2023 Activities

Preparation Workshops



MYAN held two online workshops to people for the prepare young upcoming FUSE event. The objective of these workshops was to introduce people to key young advocacv principles and provide them with ample opportunities to ask questions, brainstorm their ideas and practice their pitch delivery. The workshops were designed to ensure that the young people were well-prepared and had a clear understanding of their roles and responsibilities in relation to the pitch activity national and conference.

One of the workshops was specifically focused on developing effective pitching skills. It was framed as a pitch school where young people were taught basic principles of government relations and how to make strong recommendations. This was an important aspect of the workshops because it helped young people understand how this iteration of FUSE would be unique and how they could make an impact.





Day 1: Pitch Training

The 'pitch school' activity was an opportunity for young FUSE delegates to learn how to deliver compelling pitches to decision makers, advocate for issues that are important to young people, and gain valuable experience in crafting solutions to important issues and identifying practical ways in which problems can be addressed.

By participating in the pitch activity, delegates gained valuable insight into the process behind crafting effective solutions to issues, and using diplomacy skills to message this to decision makers, which is a crucial skill for future advocacy efforts.

To prepare for the pitch, delegates worked in small teams with MYAN's partner organisations and members of the Youth Ambassadors Network to explore the FUSE topics, identify key concerns, and develop solutions to put forward. They also practiced the art of delivering their pitch, receiving constructive feedback from their peers.





Media Training



In partnership with the Foundation for Young Australians (FYA), FUSE participants attended a workshop on how to effectively navigate the complexities of today's media landscape. Covering essential topics such as media terminology, storytelling, and the significance of media and why it matters, this training equipped FUSE participants with the necessary tools to comprehend and effectively engage with the media.

Delegates learned how to manage media interviews, frame key messages, and protect their stories. The session aimed to cultivate media-savvy leaders who can navigate and leverage the media to advance their causes and engage effectively with diverse audiences.



Day 2: "Parliamentary Speed Meeting" Event



The FUSE "Parliamentary Speed Meeting" event took place during parliamentary sitting days at Parliament House. Tailored to empower young leaders, the event aimed to offer a comprehensive understanding of parliamentary procedures and grant participants a distinctive platform to instigate change. Participants were encouraged to present their inventive solutions to prevalent challenges affecting themselves and their peers directly to parliamentarians. This interactive session facilitated an exchange of perspectives, allowing parliamentarians to gain valuable insights into issues pertinent to the youth.

FUSE Participants

FUSE 2023 participants were selected through established youth advisory networks and MYAN's state and territory partners. 28 young people were selected to participate. Delegates from urban, regional and rural locations across Australia attended, representing a broad cross section of skills, cultural backgrounds, and experience in advocacy and leadership. For many delegates, this was the first formal leadership skills development and training they had attended. All delegates were aged between 18-28 years, and represented a diverse range of cultural and linguistic backgrounds including:

MYAN National Multicultural Youth Conference

Shaping the Future of Australian Multiculturalism: Realising Potential Through Multicultural Youth Participation

National Conference



MYAN recognises that settlement is a complex process that requires the involvement of multiple stakeholders, including young people themselves, government agencies, and community organisations. Hosting a national conference on youth settlement is important for several reasons:

Provides an opportunity which allows stakeholders to share expertise on settling young people from diverse backgrounds, fostering new strategies and policies for improved outcomes, and breaking down silos for innovation and efficiency.

Raises awareness of challenges faced by migrant and refugee youth, fostering understanding and empathy, and dismantling stereotypes.

Provides a platform for young people themselves to share their experiences and perspectives on settlement. This is critical in ensuring that their voices are heard and that their needs are taken into account in the development of the policies and programs that affect them.



Welcome to the Country - Aunty Violet Sheridan

Aunty Violet Sheridan, Ngunnawal Elder, opened the conference by giving a beautiful Welcome to Country. Aunty Violet's welcome encapsulated a call for unity, respect, and acknowledgment of the rich heritage and contributions of First Nations people. Aunty Violet also stressed the importance of respecting diverse cultures, and advocated for inclusivity, unity, and Indigenous representation in decision-making.





Opening Remarks - Carmel Guerra OAM



MYAN's Chairperson, Carmel Guerra OAM, opened the conference and highlighted the importance of recognising and empowering young people to create positive change. Carmel emphasised the significant role young individuals play in shaping a better future for Australia and expressed gratitude for the diverse and talented group gathered at the event, underscoring the shared commitment to supporting and advocating for young people in the country. The speech focused on the challenges faced by children and young people seeking protection, particularly those exposed to forced migration, stressing the need for adequate support upon their arrival in Australia.

Furthermore, Carmel acknowledged the resilience and potential of young refugees in Australia, despite the adversities they have encountered. She praised the Australian Government's investment in settlement services and the development of youth-specific programs aimed at facilitating positive outcomes for young individuals. Carmel emphasised the importance of tailored support to address the unique needs and barriers faced by young people from refugee backgrounds, such as accessing employment and affordable housing. Carmel emphasised the significance of providing a platform for youth voices, inviting collaboration and partnership to drive meaningful change and create a hopeful future where all young people can thrive and contribute positively to society.



MYAN Report Launch: Navigating Youth Settlement in Australia



"In this document we measure what counts and what counts is the voice of young people who are experiencing settlement in Australia." Sandy McKiernan, YACWA CEO stated as she launched the new MYAN report, 'Navigating Youth Settlement in Australia'.

MYAN conducted consultations across Australia with over 100 young people and 90 sector representatives to understand the challenges of youth settlement in the country. The report provides valuable insights and highlights potential opportunities for advocacy at both state and federal levels, highlighting common issues such as *employment, health, social connectedness, belonging, and identity*. The document emphasises the importance of the voices of young people experiencing settlement in Australia. The importance of the report was noted, acknowledging its significance in providing crucial information for advocacy work at both state and federal levels. Sandy stressed the value of such information in advocating for the needs of young migrants and refugees, especially in regions with lower population numbers, by *presenting concrete data to government officials and local authorities.*

Furthermore, Sandy underscored the significance of the report in *amplifying the voices of young people* themselves who are undergoing the settlement process in Australia. Sandy noted that the document serves as a platform to convey the realities faced by young migrants and refugees to policymakers and stakeholders across the country, ultimately aiming to effect positive change and address the pressing issues identified through the consultations.



'Navigating Youth Settlement in Australia: Challenges and Opportunities – Report of National Consultations conducted by the Multicultural Youth Advocacy Network (MYAN)





Keynotes



Samah Shda is a storyteller, refugee protection and engagement specialist, and refugee education researcher. Samah delivered the conference keynote speech and provided a unique and personal insight into the challenges faced by individuals who arrive in new countries without any prior knowledge of the new systems and cultures. She shared her own journey, which began 13 years ago when she left Baghdad to pursue education in the US. Growing up in a dictatorship, Samah had to live in constant fear for herself and her loved ones.

However, her determination to succeed led her to secure a scholarship to study political science in a prestigious American university. Despite her success, navigating the system and accessing services in the US was a constant struggle, leaving her feeling isolated and alone. Her family had to seek safety in Turkey after the invasion of Iraq and part of Northern Syria by ISIS in 2014. After a 3-year journey, they were granted a humanitarian visa to Australia. Samah recounted her experiences of feeling safe and secure with the welcome and support she and her family received from the community and settlement service staff in Australia.

Through her story, Samah highlighted the need to do more to provide targeted support and assistance to young refugees to ease their transition and ensure their successful settlement into new communities.



Carla Wilshire, CEO of Social Policy Group, gave a fascinating keynote speech on the influence of AI in Education and Employment. The keynote speech on technology's impact on society through historical revolutions delved into the transformative power of technological advancements throughout history. It highlighted the significance of understanding and preparing for the implications of such changes. Beginning with a reflection on the Agricultural Revolution, which transitioned human societies from hunting and gathering to agriculture, leading to the development of cities and a more structured society.

The Industrial Revolution was also discussed, characterised by the shift from agrarian to industrial economies, bringing about major social, economic, and cultural changes such as urbanisation and shifts in labor patterns. The objective of the speech was to explore and address the profound impacts of technology on society, both historically and in the present and future, urging preparedness for the complex questions that arise from these ongoing advancements.





Panels

Multicultural Youth Mental Health and Wellbeing

The panel stressed addressing youth mental health in multicultural communities, emphasising *personal empowerment and collaboration while cautioning against tokenism*. Service providers' challenges were acknowledged, urging community consultation for a participatory approach. Improved diversity training for government interpreters was recognised for addressing language barriers.

The concept of "intersectionality" was introduced for inclusive embracing of diverse identities. Capacity building amid limited funding, advocating partnerships, and sustainable practices were emphasized. Learning from lived experiences, offering leadership opportunities, and valuing experiential knowledge were key discussion takeaways.



Empowering Global Engagement

A key theme of this panel was **the success of Australia's resettlement programs** and an emphasis on the need to collectively continue this momentum particularly in light of ongoing refugee crises around the world. Additionally, the panel highlighted the importance of events like the Global Refugee Forum and the UNHCR Consultations on Resettlement and Complementary Pathways being held in Australia in 2024 as important opportunities for the sector to demonstrate our leadership and share our best practice.



Navigating Education Pathways for Success

The panel discussion highlighted the importance of addressing **systemic barriers in education**, particularly the need to tackle bias and assumptions, along with implementing a whole-school approach to combat racism.

Emphasis was placed on building capacity amidst a cost of living crisis, recognising the increasing significance of vocational education, and the necessity for improved training for university educators. The panel stressed that equity should be central to educational pathways, and emphasised the **need for more comprehensive quantitative data** to effectively address challenges in the education system.





Nurturing Belonging, Fostering Connection, and Inspiring Active Participation

A prominent theme of this panel was the importance of **empowering women to take on leadership positions** by providing them with the necessary training and support. In discussing the impact on women's representation in leadership roles the panel used the example of the Seat at the Table program which aims to address the issue of underrepresentation of women in decision-making roles by equipping them with the skills and confidence needed to participate effectively on boards. The program not only provides training but also connects participants with resources and mentors who understand their unique experiences and identities.

Another important panel theme was the **concept of belonging and the critical role of support networks in overcoming imposter syndrome** and other challenges faced by women in leadership roles. The panel discussion emphasised the importance of creating a supportive environment where women can feel empowered and confident in their abilities.

This panel discussion highlighted the significance of diversity and inclusion in leadership positions and the benefits it brings to decision-making processes. These themes of empowerment, belonging, and diversity are crucial in promoting gender equality and creating more inclusive leadership spaces.



Breaking Barriers in Access to Essential Service

The panel presentation titled "Breaking Barriers - Navigating Intersectionality in Access to Essential Services" focused on strategies to overcome challenges in providing vital services. The discussion emphasised the **significance of building capacity**, especially in resource-limited settings, by consulting the community, empowering young leaders, incorporating lived experiences, and fostering collaboration to break down barriers.

Service providers were encouraged to embrace the idea of making mistakes as part of the learning process, *engaging individuals as partners, enhancing diversity training, and tailoring approaches* to the needs of specific communities while educating on broader issues. By adopting these approaches, service providers can work towards inclusivity and effectiveness in delivering essential services to all individuals.





Navigating Employment Pathways

The panel addressed *cultural safety and inclusivity* within organisations, particularly concerning First Nations peoples. It was emphasised that many organisations claim to be supportive of First Nations individuals and have internal programs in place, but in reality, they fall short in providing a culturally safe environment, leading to low retention rates and loss of talent. To address this, organisations should *conduct surveys or seek independent assessments* to determine the level of cultural safety within their workplace.

Moreover, the panel emphasised overcoming employment challenges through **broad** representation and access, prioritising bias and diversity training, and fostering accountability for a more inclusive workplace culture. Mentoring programs and addressing gatekeeping issues were highlighted as crucial for equal opportunities. Systemic change must begin at the top, with broader representation in decision-making roles to drive meaningful change.






